# • Website Domain Name Update

o GoDaddy account has been transferred to Mark AB0DX. Craig will contact GoDaddy about further discounts available for 501c3's, time invested with them, or cheaper to go elsewhere. Craig will provide an update as to the outcome of the renewal next month.

### • 440 Repeater Antenna

- Dual band antenna up now has a high SWR and is un-adjustable. Mark found an adjustable 440 antenna replacement and passed around a flyer on it. \$89.95 cost; motion by Bill KJ4SKL, 2<sup>nd</sup> by Kevin AD0CI to buy the CushCraft antenna. Motion passed.
- At Ridiculous Days, Samlec power supply failed. 2<sup>nd</sup> one of ours to fail and is out of warranty. WFD is coming up; we would like to get this replaced. Earl researched power supplies and came up with a Jetstream JTPS-31MB. This model is owned by both Mark and Jane.
  - o Cost \$90.00 and is a 30 amp surge, 25 continuous switching power supply.
  - Discussion was had about larger supplies to possibly power the trailer or charge batteries. Kevin suggests the trailer may have a converter to charge batteries. Club does have an Astron 35 amp linear supply, but it is a backup for the repeaters and is very heavy.
  - o Ben has a Kenwood power supply, excess to his needs. Motion made by Melinda KJ4SKK, 2<sup>nd</sup> by Earl N0CHN to table this discussion until Ben's power supply is checked out to see if would meet our needs. Motion passed.
